

#### Freedom of Information Act 2000 - Request Reference Fol/22/422 Sexual Exploitation

The following information has been provided by Ynys Saff, Cardiff and Vale University Health Board's (the UHB's) sexual assault service. This service provides support for children and adults presenting with either acute or historic sexual assault. Ynys Saff provides an environment for police interviews, forensic examinations, historic Child sexual abuse holistic medical examinations, ISVA support and ongoing counselling.

1. How many adults did you support during the last 3 financial years who have experienced sexual exploitation?

5 cases recorded.

2. How many adults did you support during the last 3 financial years who are at risk of experiencing sexual exploitation?

10 cases recorded

45 cases where the reported incident leading to the SARC referral was felt to be linked to CSE.

Ynys Saff work closely with Social services to discuss safeguarding plans for adults and children felt to be at risk. As part of these discussions, recommendations will be made for social services to look at risk assessments for CSE, or sexual exploitation.

Ynys Saff also link into wider networks across Wales, such as the Children's commissioner CSE/A Roundtable.

Information gathered at time of referral from the referrer, and subsequent assessments by an Independent Sexual Violence Advocate. Any concerns raised regarding sexual exploitation, or other safeguarding issues are reported using a multiagency referral form. We would submit a vulnerable adult form.
