Organisation code (code of provider)	Issue with coded identifier within Network (currently all showing 140). Have provided Organisation Identifier which will show as UHW in all cases.
Primary diagnosis (ICD-10 3 <sup>rd</sup> or 4 <sup>th</sup> digit)	Included – within the confines of disease tree included in ePMA database.
Adjunctive therapy type	Cardiff and Vale University Health Board does not hold this information.
Treatment intent	Included – currently does not match coded entries as per Data Field from NHS Data Model and Dictionary for SACT. Intents adopted from Swansea's V5 database with a view to change when this is switched off later this year.
Drug regimen	Drugs included individually with title of drug regimen above relevant group.
Clinical trial indicator	Included – but please note that any Blank entries can be viewed as 'No'.

The report was run looking only at activity within Cardiff and Vale University Health Board (CAV UHB). This means there may be patients included from outside of CAV UHB, but only in the case of CAV UHB treating them (e.g. BMT or more intensive chemotherapies not performed in other health boards). These reports will have excluded treatments that have been given at Aneurin Bevan University Health Board or Cwm Taf Morgannwg University Health Board.

The report details 328 individual patient records, showing treatments received between 01/04/2023 and 30/09/2023. While the data is anonymised, each distinct record was given a sequential number in order to match details within the report as required.

In total there are 3,812 separate drug administrations included. All supportive care has been removed but the report does refer to drugs such as dexamethasone that could be part of the regime or included as supportive – there is currently no way to distinguish between these.
