Thank you for seeking our involvement in this FOI request.

Having reviewed the attached PDFs, could I please kindly ask that you make the following adjustments to the documents listed below:

1. ANC 15 – please redact the roles [REDACTED] of the Cardiff and Vale members of staff on page 1.
2. ANC 11 – please redact the entire signature of the Cardiff and Vale member of staff in Paediatrics covering pages 2 and 3 of the PDF.

We believe that this information is exempt from disclosure as it could be used to reidentify Cardiff and Vale members of staff, thus engaging section 40(2) of the 2000 Act.

Following a balancing test of the legitimate interests of the requestor to receive the information on the one hand, and the interests and rights of the Cardiff and Vale members of staff concerned on the other, we consider that the above described personal information of our staff should be withheld as a result of the potential harm or distress that disclosure might cause them and the reasonable expectations of privacy that they hold.

Could you please therefore confirm that you will be making these amendments to the documents you intend to disclose.
